INTRODUCTION TO ACTIVE RELATIONSHIPS

What is the Active Relationships Center?

The Active Relationships Center is a company that develops curricula for resilience in careers and relationships, and for enhancing life skills and promoting wise choices. Active Relationships Center teaches the skills embodied in its curricula to the general public and also presents seminars to train professionals to teach the skills embodied in its curricula to the general public. The products of the Active Relationships Center are available for purchase by persons who have been certified by the Active Relationships Center to present the applicable curricula.

Who uses the curricula?

The curricula of the Active Relationships Center are utilized by the Armed Forces to build personal and family strength among military personnel and their families. Curricula are also utilized by federal and state funded agencies in both secular and faith-based arenas and in community based initiatives.

What is “Active Military Life and Resiliency Skills?”

The title of the specific curriculum listed in this GSA schedule is “ACTIVE MILITARY LIFE AND RESILIENCY SKILLS” (AML&RS). It is sometimes referred to in a shortened form as “Active Military.” It is written specifically for use with military personnel, their families and their partners and contains topics and skills building exercises relevant to circumstances encountered in today’s military environment as well as skills for use across life’s stages. Most important it is a curriculum to hone key skills for resiliency. Pursuant to this schedule, Active Relationships Center offers both printed products and training services related to the AML&RS curriculum.

Is the AML&RS curriculum used in classes or groups, or is it used in 1:1 sessions?

The AML&RS curriculum is generally intended for use in classes for military members, their families and their partners. Class sizes vary according to needs, but often contain ten to 40 persons at a time. However, the curriculum can also be taught in 1:1 sessions, by Family Advocacy, Pastoral Care, or Family Support/ACS professionals.

What types of AML&RS training services are offered by the Active Relationships Center?

The Active Relationships Center offers (i) a 2-day (CR2) and a 3-day (CR3) AML&RS workshop for singles and/or couples, (ii) a 3-day (PT3) “certification” seminar designed to teach chaplains and family support personnel how to present the AML&RS curriculum to singles and couples, (iii) a 7-day (CRPT7) seminar that combines the 3-day workshop for singles and couples and an enhanced version of the 3-day (PT3) “certification” seminar for professionals (designed to enhance the training of professionals by allowing them to observe/participate in an actual workshop for singles and couples) and (iv) customized workshops/seminars designed to the specifications of the requesting agency.

Is certification required before presenting the AML&RS curriculum?

Classes for military personnel are presented by Active Relationships CERTIFIED leaders. Leader certification is required prior to facilitating the curriculum. Certification may be obtained through “live” certification trainings or via the Leader Certification Kit (PR-406) offered in this schedule. The Certification Kit for AML&RS contains all the needed elements to become knowledgeable and proficient in the curriculum’s delivery.

Is it necessary to purchase Participant Books if I know how to lead the material?

Yes. Each participant should receive a book. However, couples may share a book. Participants are best served by having their own material to keep. The AML&RS curriculum consists of copyrighted material and unauthorized reproduction is prohibited.

Is AML&RS a secular or a faith-based curriculum?

Available curricula include both secular and Christian editions. The certification kit allows the trainee the opportunity to become certified in one or both, the secular or the Christian edition.

What topics are included in the AML&RS curriculum?

The AML&RS curriculum includes 24 different modules, including but are not limited to:

- ❑ Readiness and Key **Resiliency** Tools
- ❑ **Relocation** and **Transition** Skills
- ❑ Challenges of **Multiple Deployments** and **Reintegration**
- ❑ Active **Communication** Techniques for **Distance Relationships** and for Life
- ❑ Mapping **Emotional Triggers** related to Deployment or Life Experiences
- ❑ Skills for **Anger Management**
- ❑ Challenges of **Post Traumatic Stress Disorder (PTSD)** and **Traumatic Brain Injury (TBI)**
- ❑ **Conflict Resolution** Methods to minimize anger responses and to build success
- ❑ **Money Personalities**—evolving roles and responsibilities
- ❑ **Avoiding Financial Power Struggles** and learning collaboration and respect
- ❑ Tools for Creating Connections and **Intentional Traditions**
- ❑ Wise Choices for **Self Control, Fidelity and Healing Wounds**
- ❑ Recognizing and **Celebrating** and effectively utilizing **Strengths**
- ❑ **Romance** and Intimacy for Lifetime Love

Leaders may choose which of the 24 modules included in the AML&RS curriculum to cover with participants, and all the topics are in the Participant Book. Therefore ordering is easy, since there is one book with all the parts. Participant books include tear-out exercise pages so that couples can share a single book. Whatever material is not covered in class can be read at home by participants.

AML&RS Product Descriptions:

AML&RS Leader Certification Kit (PR-406):

This is for first time users of “Active Military Life & Resiliency Skills.” The kit contains a Leader Guide, one “push and play” DVD set presenting lectures for each of the 24 modules included in the AML&RS curriculum, one Smart Resolution Demonstration DVD, one PowerPoint CD, and one Participant Book. If a leader has not taken part in a live certification event, it will be necessary to order this kit and learn the material before presenting a couples/singles retreat. Once the information in the kit has been reviewed and learned, the person desiring certification must submit a two-page essay to the Active Relationships Center by email describing what was learned. If the essay demonstrates an adequate level of understanding of the material included in the AML&RS curriculum, the essay writer will be certified as eligible to present the curriculum. Leader Certification Kits may be shared among professional colleagues who wish to become certified.

AML&RS Leader Guide (PR-200):

The Leader Guide is for use by AML&RS professionals who are already certified to present the AML&RS curriculum. For those organizations with several professionals who are sharing a Certification Kit to become certified, it may be beneficial to purchase Leader’s Guides for each individual. The Leader’s Guides contain “how to” tips related to the presentation of the AML&RS curriculum, one PowerPoint CD, one SMART Resolution Demonstration DVD and, one “push and play” DVD set presenting lectures for each of the 24 modules included in the AML&RS curriculum.

Secular Participant Book (PR-150):

The secular edition of the AML&RS Participant Book contains all 24 modules and has tear-out exercise pages for a second person to enable a couple to share a book. This book is used for either singles or couples.

Christian Participant Book (PR-174):

The Christian edition of the AML&RS Participant Book contains devotional prayers and scripture text and is written from the Christian perspective. It contains all 24 modules and has tear-out exercise pages for a second person to enable a couple to share a book. This book is used for either singles or couples.

“Push and Play” DVD Set (PR-250):

The “Push and Play” DVD set includes lectures on the 24 modules presented by program author - Kelly Simpson – to allow lectures to be presented to participants via DVD if desired to save presentation preparation time. Note: if purchasing a Leader’s Guide, it is not necessary to purchase “Push and Play” DVD’s separately, since they are already included in the Leader Guide.

Power Point CD (PR-309):

Includes all the power point slides for all 24 modules. Power Point slides are editable, so that they may be changed to fit a presenter’s needs. Power Point slides may be printed out for use as tiles or posters for teaching aids for AML&RS needs. They may be assembled as a desk-side brief for 1:1 sessions. Artwork on the PowerPoint slides is original, produced especially for the curriculum. Note: if purchasing a Leader’s Guide, it is not necessary to purchase a Power Point CD, since it is already included in the Leader Guide.

SMART Resolution Demonstration DVD (PR-501):

When presenting classes using the module on conflict resolution, it is necessary to show a video demonstration of the technique. The SMART Resolution DVD has multiple demonstrations to choose from according to which audience the presenter is addressing. Note: if purchasing a Leader’s Guide, it is not necessary to purchase a SMART Resolution DVD separately, since it is already included in the Leader Guide.

AML&RS Seminar Descriptions:

Two-Day Couples/Singles Retreat (CR2): This seminar (for up to 25 couples or 50 participants) is presented by an Active Relationships Center “certified” leader and one assistant leader and includes a two-day seminar for couples/singles addressing customer specified portions of the 24 modules included in the AML&RS curriculum. The prices for these retreats include leader fees and meals, lodging and transportation expenses of the leaders but do not include participant books. Participant books (available in both Christian (PR-174) and secular (PR-150) formats) should be purchased separately by the requesting agency – typically each participant in the couples/singles retreat or each couple participating in the couples/singles retreat receives one Participant Book. The requesting agency must provide the training facility and meals, lodging, transportation and child care (if any) for participants.

The following is a typical 2-day couples/singles retreat (CR2) schedule.

Three-Day Couples/Singles Retreat (CR3): This seminar (for up to 25 couples or 50 participants) is presented by an Active Relationships Center “certified” leader and one assistant leader and includes a three-day seminar for couples/singles addressing customer specified portions of the 24 modules included in the AML&RS curriculum. The prices for these retreats include leader fees and meals, lodging and transportation expenses of the leaders but do not include participant books. Participant books (available in both Christian (PR-174) and secular (PR-150) formats) should be purchased separately by the requesting agency – typically each participant in the couples/singles retreat or each couple participating in the couples/singles retreat receives one Participant Book. The requesting agency must provide the training facility and meals, lodging, transportation and child care (if any) for participants.

The following is a typical 3-day couples/singles retreat (CR3) schedule.

Three-day Professional Training (PT3): This seminar (for up to 30 participants) is presented by an Active Relationships Center “certified” master leader and one assistant leader and includes a three-day seminar for chaplains and other family support personnel. This seminar teaches participants to present all of the 24 modules included in the AML&RS curriculum to couples/singles. The prices for these trainings include leader fees, meals and lodging and transportation expenses of the leaders but do not include AML&RS Leader Guides (PR-200) or AML&RS Participant Books (PR-150 and/or PR-174). Leader Guides and Participant Books (available in both Christian (PR-174) and secular (PR-150) formats) should be purchased separately by the requesting agency – typically each seminar participant receives one Leader Guide and one Participant Book. The requesting agency must provide the training facility and meals, lodging, transportation and child care (if any) for seminar participants.

Seven-Day Combined Training Seminar and Retreat (CRPT7): This seminar (for up to 30 chaplains and family support personnel and up to 25 couples or 50 retreat participants) is presented by an Active Relationships Center “certified” master leader and one assistant leader and includes both (i) the three day couples/singles retreat (CR3) (described above) and (ii) an expanded version of the seminar for chaplains and other family support personnel (PT3) (described above). This seminar allows chaplains and other family support personnel being trained to present the AML&RS seminar to observe and participate in a “live” couples/singles retreat. This seminar is the most desirable training model because it allows facilitators to be trained in the curriculum and then get to observe and assist in an actual retreat for singles or couples. Having the professional training followed by an actual retreat enhances facilitator skills and confidence and increases the likelihood that the new facilitator will initiate subsequent retreats. The prices for this training include leader fees and meals, lodging and transportation expenses of the leaders but do not include AML&RS Leader Guides (PR-200) or AML&RS Participant Books (PR-150 and/or PR-174). Leader Guides and Participant Books (available in both Christian (PR-174) and secular (PR-150) formats) should be purchased separately by the requesting agency – typically each of the chaplains and family support personnel being trained to present the AML&RS curriculum receives one Leader Guide and one Participant Book and each participant in the couples/singles retreat or each couple participating in the couples/singles retreat receives one Participant Book. The requesting agency must provide the training facility and meals, lodging, transportation and child care (if any) for seminar participants.
